  - The Training Completion Certificate is for chapters to print and use if desired; these will not be signed by the State office.

- TMN Listserv anyone can sign up for this. Note that members can post to the listserv. It is a moderated listserv so everything is reviewed before it is posted.
  - Advanced training topics shared on the TMN Listserv still need to be approved at the local chapter level as some may not be appropriate for your region of the state.
- TMN VMS Updates: new information was shared.
  - o Changes to the Administrative "back end" of VMS are taking place.
  - VMS admins were sent info on updates being made such as to the TMN
     Certification Status fields
  - Moving to three administrative roles
  - Let your VMS admins know to report any anomalies or weird / different things to the help desk. One tip is to log out and back in before reporting an issue to see if it goes away.
  - New: Onboarding module will include things like a mini-training module explaining the program, standards of conduct etc; for people new to the TMN program, not for existing members.
    - Question from chat: will a person need to do the VMS onboarding before applying for a chapter training? Michelle will look into this.
  - Head-up that VMS Opportunity signups will change to an "Opt In" format as compared to the current configuration which is "Opt Out"
  - Note: this is not a complete VMS system rebuild; just new features and modules
    of Samaritan not previously available.
  - There will be training sessions for VMS Admins and members at the appropriate time.
  - All chapters have submitted the requested photo for the VMS front page. Thanks!

### Presidents Questions Submitted

- The North Texas Chapter thanked those who shared information on what their chapter does for DEI (Diversity, Equity, Inclusion / Accessibility) and JEDI. There is an invitation to any interested chapters to participate in a zoom call on June 12.
- "Service" in your own backyard, yes or no?
  - Michelle answered this: If it's on your own property, and it's stewardship and management, even if it's a project that is otherwise being conducted by the chapter or an effort that is being conducted on public land but you've chosen to implement it on your own property, that is not volunteer service.
- Attendees were then welcomed to ask additional questions.
  - Can we pick up pins at the annual meeting? Mary Pearl answered: Yes. Higher level pins will be available. Will check on how other pins will be handled.
  - An attendee reported that the group rate for the TMN annual meeting is not showing on the website. Mary Pearl: yes this is one of many issues. I am checking into all of these with the hotel and will send out more information when I have it.
  - O Does picking up trash on your daily walk count under Keep America Beautiful? Michelle: Casual picking up of trash in your neighborhood is a nice thing to do-our environment thanks those who do and we are happy to have created a concerned citizen to do so but litter pickup up while out on one's personal daily walk does not fit our service guidelines and policies. The service needs to be part of an official planned event that several people can participate in while also fitting program policies.
  - Does doing the Bat Monitoring project in our backyards count for volunteer service hours, or is it disallowed per the previous comments about service in your own back yard?
    - in the case being discussed, Craig Hensley helped the chapter identify the best spots for bat monitoring and one spot happened to be in a member's back yard.
    - Craig spoke up and confirmed that in some cases the backyard location(s) were chosen and recommended the time for this should still be counted for the Bat Monitoring project.
    - Michelle and Craig will discuss the details offline. This may be addressed in the next update of the Community Science guideline document.
